We have completed an assessment of our playgrounds and outdoor areas to ensure that no child is disadvantaged by being unable to access any areas in which they might wish to play. This has identified that a sloping path is needed into one of the playgrounds; work for this will shortly be completed.
All	Pupils' awareness of diversity is increased.	The School Council have reviewed the school's approach to displaying positive and inclusive images and their suggestions have been acted upon. Our librarian ensures that we provide a range of books to reflect diversity and include minority groups.
